Learning Outcomes:

Knowledge

The course lays special emphasis on the ways we negotiate awareness and agency in relation to media representations of migrants and migrations into and out of specific geographic locations within and outside the EU. To that end, the course seeks to focus on cultural narratives of the visibility as well as the invisibility (in fiction, art, media and critical discourse) of scarcity, changed ecological circumstances, practices of exclusion, the emergence of systemic violence etc., and other forms of social and cultural anxieties related to conflict, climate and migration.

Skills

Skill outcomes will entail critical engagement with and mastery of concepts, challenges and central issues across various platforms of the cultural spectrum (i.e. print and screen media, policy papers, fiction and non-fiction renditions). Students will get hands-on experience with mapping out the ways the relations between these factors can be engaged with both at local and international levels. The realia studied and examined will include documentary realism (films for action); fiction (literary and moving image media from feature films to television); social media (with particular emphasis on Twitter, Facebook and Instagram).
