For incoming students, credits are assessed on the basis of their acquisition, i.e. the degree of compliance of the completed instruction with the given study programme is assessed by the study supervisor. ## 8. Spatial, material, and technical provision of the study programme and support

a) List and characteristics of the study programme classrooms and their technical equipment with the assignment to learning outcomes and courses (laboratories, design and art studios, studios, workshops, interpreting booths, clinics, priest seminaries, science and technology parks, technology incubators, school enterprises, practice centres, training schools, classroom-training facilities, sports halls, swimming pools, sports grounds).

For teaching purposes, there are 9 classrooms in the building with the following capacity: A1 - 220 seats, B2 - 120 seats, C1 - 30 seats,

C3 - 30 seats, C4 - 80 seats, D1 - 40 seats, E1 - 20 seats, E2 - 30 seats, E3 - 40 seats.

Classrooms are equipped with new furniture (benches and chairs) and all are equipped with teaching aids – laptop, data projector with projection screen, and blackboard. Classrooms E1 and C3 are specially equipped as computer classrooms, in which laptops for students are also installed (16 in C3 and 10 in E1). Classroom C3 is also equipped with a interactive touch whiteboard. Computer classrooms are mainly used for teaching computer science and languages. Room C4 is furnished as a special classroom for audiovisual teaching. Room A1 is a fully equipped university auditorium, built in 2005, with complete equipment and facilities. It is fully air conditioned with centrally controlled air conditioning. Similarly, the entire lighting with a lighting ramp on the stage is controlled from a central control point, where the controls of audio, video and information technology are also located.

In addition to the classrooms, there are 6 department rooms available for the needs of teachers of the theology study programme, in which preparations for teaching and consultations with students take place.

characteristics of the study programme's information management (access to study literature according to course information sheets, access to information databases and other information sources, information technologies, etc.).

All workplaces and all classrooms are connected to the university network. The faculty has a newly built computer network through its ICT project solution based on manageable switches with a speed of 1 Gbps, the new structured UTP cabling enables the transition to a speed of up to 10 Gbps. All classrooms are equipped with a data projector, an electric screen and a computer connected to a computer network; the computers in the classrooms are centrally managed, and the computer centre is equipped with new powerful servers. This creates technical conditions for the use of modern information technologies by KU Faculty of Theology staff and students. Students must log in to the faculty network, each student has their own password and access rights. The KU Faculty of Theology has 2 teaching classrooms of computer technology. The university-wide information systems include the Academic Information System (AIS), which is used to manage the study. All necessary information is available to students on the faculty website, or the websites of individual departments. Teachers also provide students with teaching materials in digitised form, communicate and consult with students through electronic communication, and through the website.

The faculty has 9 classrooms equipped with a computer connected to the network, a data projector and an electric screen, 1 classroom with an interactive whiteboard and three rooms have sound systems installed. All workplaces and all classrooms are connected to the university network, special software is available (statistical software, e-learning systems, internet media, resources allow students with disabilities to participate in the entire teaching process.)

The KU Faculty of Theology has a faculty library at its headquarters, which is a branch of the KU University Library. The library has a separate section with an area of 500 m<sup>2</sup>. Library materials are freely accessible to students. Most library materials can be borrowed. Before entering the library, there is a bibliobox accessible outside the library's working hours.

For part-time study, a study room with 20 study places equipped with a computer is available in the library. The staff of the faculty library also provides students with an interlibrary loan service and information-library counselling per student needs during business hours. The catalogue of books and periodicals is available online, so it is also possible to search in the library collection using computers outside the library (the library uses the Virtua system). The faculty library's total collection represents more than 25,000 book titles and scientific journals (146 of which are domestic and 96 are foreign).

Composition of the library collection with a content link to the field of study of Social Work: philosophy, ethics, sociology, psychology - 3050 vol.; nursing - 81 vol.; missiology and ecumenism - 1634 vol.; social work - 415 vol.; law - 407 vol.; pedagogy - 692 vol.; languages, dictionaries, encyclopaedias - 1418 vol. Periodicals: Acta Missiologica, Bibliographia Missionaria, Donn Bosco dnes, Família, Hlas – Zrno (Zrno – hlas, zrno), Hlasy z domova a misií, Mondo i missione, Rodina a práca, Rodinné spoločenstvo, Sociálna politika a zamestnanosť, Sociológia, Sociologický časopis, Svetové misie, Nové mesto, Sociálna práca / Sociální práce, Verba theologica, Rodina a zodpovedné rodičovstvo, Verbum, Viera a život, Duchovný pastier, Katolícke noviny, Slovo, and others.

Online resources and information databases are accessible in study areas of the library. The following databases are currently available for students: Web of Science, Scopus, ProQuest, SpringerLink, Wiley Online Library. The entire university has secure access to professional databases that can serve students to supplement and expand their knowledge from around the world.

Students have access to a wireless Internet connection in faculty facilities. They may also make use of 22 kiosk-style Internet-connected terminals using the SUNRAY2 system supported by a SUN FIRE X2270 terminal server.

Students have access to the AIS2 academic information system (ais2.ku.sk), where the study agenda is registered. A student license for MS Office 365 is also available.

The KU Faculty of Theology guarantees that the basic and recommended literature listed in the course information sheets for the Charitable and Missionary Work study programme is available in the University Library in Košice. In connection with the introduction of distance learning, many study titles are already available online or on CD.

c) Characteristics and extent of distance education applied in the study programme with the assignment to courses. Access, manuals of e-learning portals. Procedures for the transition from contact teaching to distance learning.

The Catholic University of Ružomberok uses the e-learning system to support the teaching of online education in the Moodle environment. It is accessible at <a href="https://moodle.ku.sk/">https://moodle.ku.sk/</a> and it contains basic information, courses and manuals. The electronic e-learning system in the Moodle environment is available to all students, teachers and staff of the Catholic University to improve the quality of teaching.

In the case of critical conditions for the part-time form of education, we plan to implement a partial transition to the distance form of education in the study programme. Interactive lectures using MS Teams and feedback through didactic tests in MS Forms or MS OneNote for Classroom have proved to be the best during the period of study during the Covid pandemic, as students and teachers have the necessary licenses for this software. In 2020, teachers were trained to use these resources in their teaching. Teaching through the MS Teams system using a live video connection with students has proved very successful in all given study programs in the given circumstances. Neither students nor teachers reported significant problems.

Support in using ICT technologies is provided to students and teachers by the faculty's ICT officer Ing. Anton Babják, PhD.

Courses with content of a more practical focus are delivered in a sensor manner in accordance with current epidemiological measures.

The results of this education are recognised by the institution. Mobility is regulated by the Study Regulations in the section on the organisation of educational activities. The dean / rector or the vicerector for external relations grants approval for mobility. Part of the study is recognised in accordance with the contract, the European standard and the European Credit Transfer System. Documents are issued at the Catholic University in Ružomberok in accordance with the provisions of Act No. 131/2002 Coll. on Higher Education Institutions and on amendment of certain acts, as amended. For posted students, credits are assessed on the basis of their acquisition, i.e. the degree of compliance of the completed instruction with the given study programme is assessed by the study supervisor. If interested, the student can enrol in courses at their home institution and complete them remotely, if the nature of the course allows. Motivational videos, processes, procedures and instructions for registration, selection and implementation of mobilities are published on the website: The website https://www.ku.sk/medzinarodnevztahy/strategia-internacionalizacie.html has published versions of all strategic document, methods of internalisation at the university, the rector's directive and other accompanying documents.

The long-term intention and strategic goal of the university is to prepare quality graduates in accredited study programmes. The prerequisite for achieving this goal is to admit to study those students who meet demanding quality criteria. The University has developed a system of procedures for the admission of students developed in the Study Regulations and in the Rector's Admissions procedure measure.

The application is accompanied by a dissertation project in the range of 3-4 pages (justification of the choice of topic, goal, methods, expected outcomes, literature and an approximate scheme of the work). The application states which of the two foreign languages on offer they wish to take the admissions exam.

#### Form of the admissions exam

The content of the written entrance exam is an examination of the basic knowledge of a master's degree in a given field in the form of a test and an exam in two world languages. The language exam consists of writing a brief justification of the decision for doctoral studies in the first chosen foreign language and a descriptive translation of the submitted article from the second chosen language into Slovak.

Applicants choose from these foreign languages: English, German, French, Spanish, Italian, Russian.

The content of the oral entrance exam is a presentation of the framework project of the dissertation, which the candidate has chosen. The applicant submits a written proposal for the selected topic of the dissertation, which contains: justification of the choice of topic, goal, methods, expected outcomes, literature and an approximate scheme of the work.

## 10. Feedback on the quality of provided education

a) Procedures for monitoring and evaluating students' opinions on the study programme quality.

The organisational and legal aspects of the procedures for monitoring and evaluating students' opinions on the quality of the study programme are prepared in accordance with the rector's directive "Policies, Procedures and Rules of Study Programmes at the Catholic University in Ružomberok" as published on the KU Faculty of Theology's website at: <a href="https://www.ku.sk/app/cmsFile.php?disposition=i&ID=1222">https://www.ku.sk/app/cmsFile.php?disposition=i&ID=1222</a>.

The Catholic University in Ružomberok has developed a mechanism to use the results of assessments of teachers by students. With respect to obtaining feedback on a teacher's pedagogical performance, one of the means at the university and its faculties is an anonymous questionnaire, which is used to map indicators of the quality of education and to facilitate the acquisition of feedback from students. This provides an opportunity for a deeper analysis of the quality of the teacher's teaching, streamlining teaching and improving the teacher's didactic and social competencies. The aim is to increase the satisfaction of teachers with their own performance in the educational process and the satisfaction of students with the quality of teaching. Student feedback related to the effectiveness and availability of supporting material, technical and information resources is primarily identified at all faculties through a questionnaire to assess the quality of education. The results of student questionnaires on the satisfaction and quality of the educational process are archived at the faculty.

Another questionnaire into the employability of KU Faculty of Theology graduates is also evaluated (archived at the faculty).

Teachers and courses are evaluated by the students at the end of every semester at the Faculty of Theology. Assessment is performed through the "Survey" functionality in the AIS2 academic information system, which ensures that the student completes the assessment only once and evaluates only the courses for which they are registered in the given semester and only the relevant teachers. Students can also add a verbal comment to the questions. Students' answers are evaluated at pedagogical meetings, which take place at the beginning of the semester, as well as at departmental meetings, where specific measures are taken to increase the quality of education.

Educators can view their evaluation in the AIS2 academic information system and compare it with average values. They can also view verbal comments. The heads of departments see the evaluation of all teachers of the department. The dean and vice dean for education can view the evaluation of all teachers.

The graduates of the faculty are contacted via email 6 months after the end of their studies, in which we ask them to fill in the evaluation questionnaire. They comment comprehensively on their completed studies at the faculty. Graduate questionnaires are conducted through the Google Forms application. The results of the graduate evaluation are discussed by the relevant bodies of the faculty management, which also take measures to ensure the improvement of the quality of education.
