Fresh Air is about the relationship between a single mother and her daughter living in a derelict housing estate in post-communist Hungary. Their space features not only as part of the visually powerful narrative of the film, but also as a constitutive element in the subjectivity of the protagonists. Working as a public toilet attendant at an underground station, the mother desperately tries to appropriate her space, both abject and brutal, whereas the daughter, studying to be a dressmaker, pushes her spatial boundaries by designing dreamlike dresses. In their claustrophobic physical, psychic and social space, their femininity and female sexuality play a key role: though differently, they are exposed to gazes, bullying, and brutality, while also struggling with each other in a space that is both the simulacrum of a dream world and their everyday post-communist reality.

The volume is based on a conference in a prestigious series of international conferences organised by the European Society for the Study of English (ESSE), held biannually, where the thematic seminars are organised by co-convenors from two different national member societies of ESSE, in this case by Éva Antal (Hungary) and Antonella Braida (France) on 18th-century women writers. The seminar was open in its appeal in terms of interdisciplinarity, and the volume itself broadened the spectrum by inviting authors from the discipline, like me for a contributor. The volume is structured into four main parts (Cross-Cultural Connections across the Channel; Writing the Female Self and (Self-)Education; Reading and Experiments in Form; Women's Critical and Economic Thought), reflecting on the diversity of literacy in which 18th-century women participated. In this way, the volume offers a comprehensive overview of how (privileged) women in the 18th century got engaged in cultural dialogues and debates, monstly in the context of the enlightenment and the literature of sensibility that defined women's place in a limiting way. The volume partly negates this view by showing counterexamples, and also analysing women writer's involvement in the aesthetic-philosophical debates of the age. Nóra Séllei's articles contributes to the volume in this vein: by re-reading a seminal text by Mary Wollstonecraft, emphasising an aspect (the body and embodiment) that has never been in the forefront of analytical discussions so far.

The female body and feminine embodiment have always haunted western philosophy as a problem. Mary Wollstonecraft's Vindication, written in a period when the cult of sensibility put the notion of the body into a new perspective, engages with the issue of the female body in multiple, and sometimes contradictory ways. The article explores her approach to the female body and embodiment in her Vindication, and investigates how the female body is compared to the male body in the contemporary cultural-philosophical context, how the female body is related to feeling and the intellect, how it is seen as the result of education, furthermore, how Wollstonecraft argues for the idea that what we today call embodiment has an impact upon the mind and the intellect.

The text was written as a solicited research article: the result of a direct request coming from the journal editors for a special issue of *Vigilia* on New Zealand culture.

The article has a double focus, reflected in the subtitle of the article (in English: Katherine Mansfield: A modern individual and a modernist writer): so partly, it addresses the issue of how social norms and society changed in the period of modernism, the early twentieth century, with an emphasis on how the notion of femininity was in a radical process of transformation, an issue that has relevance on even today's social norms and social changes.

As mentioned above, the article has a double focus, reflected in the subtitle of the article (in English: Katherine Mansfield: A modern individual and a modernist writer): so partly, it addresses the issue of how modernism as a way of writing functions, what narrative methods it uses, and what the specificities of Mansfield's writings are. The book chapter is a contribution to a major undertaking: a seven-volume, definitive history of English literature (https://kijarat.hu/termek/az-angol-irodalom-tortenete-7-kotetben/), in which I participated as the author of several chapters, and also as the co-editor of volume 5 (https://kijarat.hu/termek/az-angol-irodalom-tortenete-5-kotet-a-viktorianus-es-a-modernista-idoszak/): the Victorian and the modernist period. This chapter is a contribution to the last volume on contemporary English literature.

The book chapter, quite like in some other publications of mine, has a double focus: apart form issues of narrativity and intertextuality, it addresses the socio-economic situation concerning race and gender, including cultural norms pertaining to them, in the context of the narrative - issues that are still relevant in contemporary culture.

As indicated above, the book chapter has a double focus, one of which is the issue of narration and intertextuality, namely: Rhys's text is clearly the intertextual re-writing of Charlotte Brontë's *Jane Eyre*, written in a unique narrative mode: the two protagonist's alternating (very often parallel) first-person narration. These special features of the text as analysed in the chapter provide the grounds for introducing notions of intertextuality in the literature classroom, while also exploring broader issues like how narrative truth emerges.
