Based on an analysis of both quantitative and qualitative data collected in 2018 from the Žilina region in Slovakia, this paper intends to examine the relationship between parental mediation and parental digital media competence within households of children ages three to eight. Parent participants were recruited through schools that reflect the geographic representation of the entire region. In addition to 517 surveys, six onsite interviews with parents and observations of children interacting with digital media were collected. The research findings show that almost 50% of the children studied have access to tablets and laptops. The use of these digital devices increases with age. Qualitative data found that age and other contextual factors played a crucial role in the type of parental mediation implemented at home while quantitative data showed a significant positive correlation between parent's digital media competence and parental mediation behaviors such as enabling mediation, technical mediation, and monitoring.

The text is the result of research that significantly complements the domestic and international scientific discourse on the use of digital media in the group of children in early childhood, including in terms of parental mediation - a topic that is abroad, especially in the US, systematically researched, but in the context of the Slovak Republic and Central Europe, this area is considerably undersized. The text offers findings that allow a better understanding of the user habits of children and their parents in relation to digital media, which can help to better understand user habits even in old age, where digital media, especially the Internet, often show symptoms of extensive internet use even with elements of Internet addiction, which has a destructive impact on the individual, his/her social relations in a narrow or broad sense.

Tento príspevok ponúka zistenia založené na analýze údajov získaných z prieskumu v roku 2015 medzi 286 deťmi a dospievajúcimi na Slovensku. Táto štúdia zisťuje, aké sú vzorce používania stránok sociálnych sietí (SNS) medzi slovenskými deťmi a dospievajúcimi. Výsledky dokazujú, že sociálne siete sú medzi mladými ľuďmi obľúbené a dokonca aj deti mladšie ako 13 rokov majú profil nasociálnych sieťach a hlavne majú prístup na internet doma. Majú tendenciu tráviť viac času používaním sociálnych sietí cez víkendy ako počas školských dní. Väčšina rodičov neuplatňuje obmedzenia týkajúce sa používania internetu a sociálnych dietí. This paper offers findings based on analysis of data drawn from a 2015 survey of 286 children and ado- lescents in Slovakia. This study investigates what the patterns of use of Social Networking Sites (SNSs) are among Slovak children and adolescents. The results demonstrate that SNSs are popular among young people, and that even children younger than 13 have SNS profiles, and mainly access the Internet at home. They tend to spend more time using SNSs at week- ends than on school days. The majority of parents do not apply restrictions in relation to Internet and SNSs use. The study aims to determine what factors predict the use of SNSs. Factors such as sex, age, time spent on the Internet, viewing SNSs as a freer place, and experience with cyberbullying were taken into consideration.

The study presents the results of qualitative research focused on journalism students and their attitudes towards alternative media. The aim was to find out how they perceive alternative media in relation to traditional media and the spread of misinformation. The research is based on in-depth interviews with eight first-year students of the journalism study programme. The interviews show that the perception of alternative media is not uniform. On the one hand, they are perceived as a space for opinions that do not get attention in the mainstream media, on the other hand, they are also perceived as disseminators of misinformation. Despite the impossibility of generalisation, it is interesting to note that the respondents have no experience of systematic media education addressing verifying information and media credibility.

The issue of alternative media is currently very topical, as it is linked to other social issues and challenges, such as the polarization and fragmentation of society, loss of trust in institutions, hybrid threats, etc. Research into alternative media, including from the audience's perspective, can help to understand the factors influencing changing media habits in society.
