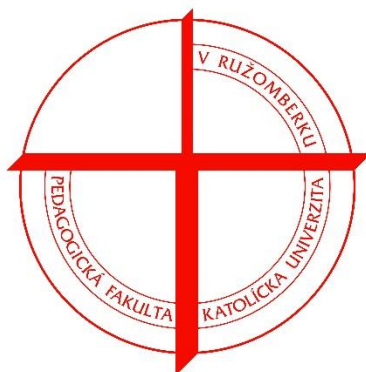

**Directive of the Dean of the Faculty of Education, CU no. 2/2022
on the implementation of joint study programs
in English at the Faculty of Education,
Catholic University in Ružomberok**

Article 1

General provisions

1. The Faculty of Education of the Catholic University in Ružomberok (FE CU) conducts studies in a joint study program according to § 54a, Act no. 131/2002 Coll. about universities. Students admitted to a study program provided by several universities complete individual parts of their studies at individual universities. The conditions of cooperation between universities will be determined by the agreement of universities. In particular, the agreement will determine the conditions of admission to the study program, the conditions of completion of the study program, details about the organization of the study, the awarded academic title and details about the documents on the completion of the study. A student accepted to study a joint study program is a student of all cooperating universities during his studies.
2. Studying in accredited joint study programs that take place at FE CU is ensured in cooperation with partner schools. These are accredited institutions of higher education from Slovakia, other member states of the European Union or from other countries. Partner universities joined in a consortium (consortium) jointly regulate the conditions and rules of study in a consortium agreement. Since universities operate in different countries, different national and institutional legislation applies to the study and its parts. Study Regulations of Faculty of Education, CU apply to the part of the study provided by FE CU. In case of inconsistency between the provisions of the Study Regulations and the consortium agreement, the provision of the consortium agreement applies to the study, as it is a document approved by all partners of the consortium.

Article 2

Study

1. Applications for studies in joint study programs are submitted through the websites of joint study programs. The admissions committee, conditions for admission, deadlines for submitting the applications and deadlines for announcing the results of the admissions procedure are approved by the consortium's management committee.
2. During the study period at FE CU, the student is assigned access to CU information systems (especially AiS2, Moodle FE CU and Abakus). The study program is carried out according to the Academic Year Schedule of the FE CU. Students of joint study programs do not enroll in the General core subjects of FE CU, as only part of their studies take place at the Faculty of Education. Students do not register for exams through the FE CU information system, but in a way agreed with the subject teachers.

3. The control of study results at FE CU is carried out by the Study department after the end of the study part at FE CU, i.e. after the end of the semester. Afterwards, the other schools of the consortium are informed about the results of the students' studies.

Article 3

Final Thesis and Graduation

1. The basic requirements that must be met by the final thesis are regulated by the document approved by the consortium. The consortium also approves the method of publishing the topics of final theses and the deadline by which students are required to choose their topic and supervisor.
2. The final thesis must be written in English. The student does not have to submit a printed version of the final thesis to FE CU.
3. State exams and graduations are held on dates determined by the consortium. The student registers for the state exam at the university where this exam is held.
